2018 World DTL Overseas Competitor Required Forms

1. All applications must be in English.
2. Each permit/application is \$75 AUD. Credit card details are on the P634 form to be completed for payment.
3. All competitors must complete the P634 'Application for a Firearms Permit' and complete the 'Overseas (temporary) Visitors competitor legitimate reason' form.
4. The cut-off date for applications for the 2018 World DTL event in Wagga Wagga is November 10. Administrators compiling information for their National Teams should collect these forms and email in one email to the admin email below
5. All overseas competitors will need to go to the following links. Select the required forms and print off. Complete each application form and sign before scanning and sending via email to Sue at admin@claytarget.com.au at the ACTA office for recording and forwarding onto the NSW Firearms Registry for processing in batches and or by country. All applications must be completed correctly for processing. No applications will be accepted unless in a Word Doc or pdf. All documentation must also be specified and attached where required. Please place in the subject line of your email; **2018 International permit.**
6. Overseas competitors will need to access the links specified below. The first link is for the P634 Application for a Firearms Permit and the Overseas temporary visitor competitor legitimate reason form.

7. A minor competing in the World DTL will need to complete the P634 and the 'Competitor to complete Overseas (temporary) Visitors competitor legitimate reason' form.

8. Any parent/supervisor who **IS** competing in the World Event must complete the P634 and the 'Competitor to complete Overseas (temporary) Visitors competitor legitimate reason' form. On the legitimate reason form, the parent/supervisor must note that they are also supervising a minor as a legitimate reason.
9. Any parent/supervisor who **IS NOT** competing in the World Event must complete the P634 and the 'Competitor to complete Overseas (temporary) Visitors competitor legitimate reason' form. On the legitimate reason form, the parent/supervisor must also note that they are also supervising a minor as a legitimate reason.

NOTE: A parent/supervisor competing or not competing must complete the same forms regardless. If a parent/supervisor is importing a firearm, they must also complete the B709 form. Parent/supervisor are to submit evidence of their authority to possess and use firearms from country of origin.

10. LATE APPLICATIONS CANNOT BE GUARANTEED.

11. All Competitors are to ensure they have contacted their airline carrier with all relevant paperwork and details in relation to their firearms.
12. Exporting firearms after the event is not controlled by the Firearms Registry.
13. In NSW and at the National Grounds and in NSW A minor must be under direct supervision by a licenced adult at all times.
14. All international competitors firearms must be stored in the ACTA grounds safe at all times when not in use.
